1. Nonprofits- 501C (3) The Fee is \$150.00 dollars for nonprofits.
2. For-profits-The fee is \$300.00 dollars for corporations and for-profit organizations.  
(Fee required for companies or individuals that are for profit and are not Marade sponsors).
3. No racial, sexual, cultural or other forms of bias will be permitted.
4. All trash must be bagged and tied. All boxes must be flattened and put into trash bags
